1. That DHARAMPAL SHASTRI EDUCATION SOCIETY is a registered society under the SOCIETY REGISTRATION ACT, 1860.
2. That RISHIKUL ARYA PUBLIC SCHOOL running under DHARAMPAL SHASTRI EDUCATION SOCIETY is of Non-Proprietary Character.
3. That the School is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
4. That no part of income from the institution is being and will be diverted to any individual in the society. Management committee or to any other person/entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to Developmental Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.
5. That school is not paying any charges towards using name motto, logo or any other non-academic activities to any other institution organization or body.

That the School will not open classes under CBSE pattern particularly class IX/XI/XII and will not use CBSE name in any manner without obtaining affiliation.

That the principal and correspondent/manager of the school have individually done through the provisions contained in the affiliation & examination byelaws and



the circulars issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.

8. That the School will ensure compliance of all statutory requirements like EPF, ESI, and labour Laws etc. with respect to the school and staff of the school.

9. That the school will ensure that the building safety Fire Safety, Water Safety Health and Hygiene certificate are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.

10. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliations by-laws are available with the school before starting classes.

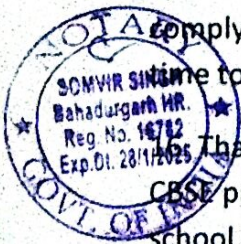

That in case affiliation has been with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/affidavit to the effect that the school has complied with all the conditions imposed by CBSE and the post-affiliation conditions contained in affiliation bye-laws along with general rules.
